➤ DODD Director—Governor DeWine selected Jeff Davis as the new Director. Jeff Davis previously served as a deputy director at DODD from 1991 to 2007 and oversaw legislative and rule-making activities. During his previous tenure at the department, Davis also oversaw public information and parent and self-advocacy initiatives. Davis has also served as director of integrated health services for Buckeye Community Health Plan, a managed care plan that contracts with the State of Ohio to provide services for Medicaid recipients.

Davis joined OPRA in 2011 as the organization's director of government affairs. In this role, he acted as the organization's voice at the Ohio Statehouse and coordinated feedback on and the implementation of statewide policy issues affecting Ohioans with developmental disabilities. OPRA's membership includes more than 150 for-profit and non-profit organizations providing services to people with developmental disabilities.

RESOLUTION 19-01-06

APPROVAL OF COLLECTIVE BARGAINING AGREEMENT WITH THE OHIO ASSOCIATION OF PUBLIC SCHOOL EMPLOYEES LOCAL 044 FOR THE PERIOD JANUARY 1, 2019 THROUGH DECEMBER 31, 2020

- WHEREAS, the collective bargaining agreement (hereinafter CBA) between the Portage County Board of Developmental Disabilities (hereinafter Board) and the Ohio Association of Public School Employees Local 044 (hereinafter OAPSE Local 044) expired on December 31, 2018, and
- WHEREAS, the OAPSE Local 044 and Board negotiation teams reached tentative agreement on a new two-year CBA on January 9, 2019; and
- WHEREAS, the Superintendent has received notification that the OAPSE Local 044 membership ratified the tentative CBA on January 16, 2019; and
- WHEREAS, negotiations for a successor CBA began December 17, 2019 and resulted in a 'tentative agreement' which provides for a successor CBA for the period January 1, 2019 through December 31, 2020 that includes the following provisions: That OAPSE covered employees receive a fifty cent (.50) per hour wage increase effective September 1, 2019 and a fifty cent (.50) per hour wage increase effective September 1, 2020; Health insurance language that provides that employees will receive health benefits and pay premiums in the amounts as determined by negotiations with PCEADD Unit A, with the exception that the part-time employee share for family coverage remains at 17%.; Increased the longevity payment amount from \$228 to \$250 which is received as a one-time payment upon completion of 9, 12, 15 and 20 years of service; Miscellaneous administrative changes including deleting the Fair Share Fee language and deleting language regarding 240-day employees; and

WHEREAS, the Superintendent, the Director of Human Resources, the Supervisor of

Transportation Services, and the Board's Labor Consultant Attorney Ronald Habowski herein recommend approval of the two-year CBA with OAPSE Local 044 as presented at this regular meeting on January 16, 2019; now therefore be it

- RESOLVED, that the Board hereby approves the CBA between OAPSE Local 044 and the Board for the period January 1, 2019 through December 31, 2020; and be it further
- RESOLVED that the Board herein directs the Superintendent to submit this CBA to the Portage County Commissioners requesting their action on the CBA for the period January 1, 2019 through December 31, 2020; and be it further
- RESOLVED, that the Superintendent or his/her designee is hereby authorized to take any and all actions to carry out this CBA.
